### 4: What needs were addressed?

Our day-to-day activities remain the needs that were addressed: Physical, Speech, Recreational and Occupational Therapy as well as counselling for families that were in need of such a service and Social Work intervention when called for. Nutrition Education and our Food Pantry are also included in what offer along with Spiritual Support if requested.

### 5: What method of evaluation did you use to monitor and measure the project's outcome and what are the result?

Since many of the diagnosis we specialize in at TeletonUSA are chronic and degenerative, our optimal goal is to have each patient increase their quality of life. Our mission is to ensure patients and their families become inclusive members of society, obtaining the ability to live comfortably and without marginalization. For the period covered for this grant we used standardized clinical instruments as well as industry standard outcome measures to track objective progress (such as the PDMS-2, VMI, and BOT) as well as patient/family satisfaction and inclusion surveys. These tools gauge current function, levels of independence, and perceptions regarding disabilities. Assessments are completed every 6 months to ensure our model of care produces positive, measurable results. TeletonUSA assess each patient's strengths and weakness to design individualized programs, ensuring each patient can produce the best possible outcome.

### 6: Do you plan to continue this project, and if so, how do you plan to sustain it?

We do indeed plan to continue our operation, in fact well into the future. Sustainability will be enhanced by a Fundraising Plan that now includes, in addition to grants and of course our annual Telethon, expanding our donor base through the use of direct marketing, special campaigns throughout the year (i.e. Giving Tuesday and End of Year), as well as a more aggressive effort in the areas of Major Gifts and Special Events. Further, CRIT has been approved for Medicaid Reimbursement and that should provide a significant source of new revenue.

#### 7: Please provide any other comments ot information relevant to this grant.

We are very pleased that we received a grant from the Foundation. We are also honored that the Foundation Staff will be visiting CRIT on Thursday, 21 February. At the time they will be able to see CRIT in action.

To date we have 217 San Antonio families on our Waiting List. With an infusion of revenue we would have the ability to serve many of those families on the list. that is our sincere hope at this time.
