Our objective of serving 3,300 children fell slightly short by approximately 150 children. Registration for our Happy Feet event is where we fell short primarily due to fewer applicants currently incarcerated at the Bexar County Jail This was due to an unusual number of codes in the jail during the sign up period, resulting in fewer classes being taught, which is our primary vehicle for acquiring applications for the children's events. Our other significant measure, recidivism, was lower than the planned 10%, coming in closer to 5% for the year, which was a substantial improvement.

3: Please explain any changes from the original proposal and the circumstances that lead to the modification of the objective.

As stated above, the application process in the jail was interrupted due to more codes in the jail than normal. We have changed our process to collect applications year-round in order to avoid this issue moving forward

4: What needs were addressed?

Children were impacted in the following ways:

Light Up a Child's Heart Christmas - children received Christmas gifts that in most cases were the only gifts they would receive based on the family situation. Each child received two gifts and were able to experience a true holiday season.

Happy Feet - children received gift cards for new shoes, an Easter basket and a refill on school supplies

5: What method of evaluation did you use to monitor and measure the project's outcome and what are the result?

Applications for each event were taken and tallied to compare to the planned attendance, and Jail re-arrest records were obtained to measure recidivism for parents of the children attending our events. As stated above, we fell slightly below our attendance figure and performed better than planned for the recidivism measurements.

6: Do you plan to continue this project, and if so, how do you plan to sustain it?

Yes, we will continued all three events and they will be sustained by annual grant applications, individual donations and in-kind gifts provided by individuals and corporations.
