Parents are especially grateful for our program because most, if not all, of them cannot afford even a minimal cost to send their children to a camp or daycare during the summer while they work. Children who were campers come back as volunteers and junior counselors because they see the value in camp.

Yes. We are the only free program in our area, and parents depend on us. We continue to apply for as many appropriate grants as we can find and hold fundraisers. Our hope is that eventually there will be enough for us to sustain ourselves, but we are not there yet. We have some new fundraising ideas for this year including looking into sponsorships.
