2: Were the objectives cited in your original proposal met? Please address each started objective and how it was met.

The Najim Family Foundation awarded \$50,000 to Rotary Club of San Antonio Foundation to support demolition and construction costs for a new Kingdom for Kids courtyard play structure at House of Neighborly Service. The project included three major parts: 1) Demolish existing play structure and erect new play structure for 2- to 5-year olds, 2) Complete half-court basketball court including resurfacing, striping and in ground goal, 3) Landscape improvements and miscellaneous clean up. These objectives were met over a two-day period with the help of Rotarian and City Year volunteers. The new play structure, deck and fencing and basketball court were completed on time and within budget. The completed structures transformed the play area at the House of Neighborly Service and provided more opportunity for use by the clients served by the facility.

3: Please explain any changes from the original proposal and the circumstances that lead to the modification of the objective.

The original proposal included a request to fund a second Kingdom for Kids at MLK Academy. The Rotary Club of San Antonio took responsibility for the funding of this project.

4: What needs were addressed?

The existing play structure and surrounding grounds were in disrepair and potentially unsafe for the people served by the House of Neighborly Service. The new play structure will serve 2- to 5-year olds. The half-basketball court and new decking and fencing will serve all members of the facility. These improvements will impact the lives of the 1,500 people a year served by HNS.

5: What method of evaluation did you use to monitor and measure the project's outcome and what are the result?

The Rotary Club of San Antonio consulted with House of Neighborly Service prior to the start of the project. Our goal was to address the issues they felt were most pressing and immediate. The completed project met their needs and goals.

6: Do you plan to continue this project, and if so, how do you plan to sustain it?

This project is complete. House of Neighborly Service will maintain the improvements.
