Program / Project Description:

Ella Austin Community Center provides a year-round academic enrichment program using a STEM curriculum focus and a reading intervention initiative from elementary and middle school-aged students. We are currently seeking funding for our new youth program, the At-Risk Youth Behavior Prevention Program - Intensive Reading Intervention Initiative. This program is designed to provide the support necessary to narrow the achievement gap with the East side San Antonio's disenfranchised youth by providing Texas Essential Knowledge and Skills (TEKS)-based instructional delivery and curriculum. We provide one-on-one and small group reading sessions and learning time in a safe and supportive atmosphere for 1st through 3rd-grade youth through a special partnership with the San Antonio Independent School District, working with the Reading staff of Artemesia Bowden Academy. Because Ella Austin Community Center fosters family stability and youth academic success, this program goes hand-in-hand with East side community development; the program is built both on family-centered youth development and evidenced-based strategy development which include intensified delivery and increased learning time. It is imperative to note that this program is made available at no cost to the participants, as this area of District 2 historically serves some of the most disenfranchised and under-served families in Bexar County

Under a data-sharing agreement with San Antonio Independent School District's Bowden Academy, the Ella Austin Community Center will provide student and comprehensive-level data on the impact of the At-Risk Youth Behavior Prevention Program - Intensive Reading Intervention Initiative. Measurement tools for the program include measure of academic progress (MAP) assessments, Fountas & Pinnell Text Level Gradients, and their student report cards to measure the effectiveness of student reading proficiency and progress. We will utilize an internal/manual data reporting system using Microsoft Excel to demonstrate student progress throughout the year.

While the Ella Austin Community Center is the lead organization, the Youth Development Department also involves a broader network of partners that offer a variety of additional services/classes that when taken together help youth along a deliberate path to success. Partners include San Antonio Independent School District, St. Philip's College, the University of Incarnate Word, Family Services Association, San Antonio Metro Health District, Gemini Ink, Martinez Street Women's Center/ Girl's Zone, Communities in Schools, and many more.

The Ella Austin Intensive Reading Program runs Monday through Friday during the academic school year as well as extended hours during the summer months and school holidays, such as Thanksgiving and Spring Break. Utilizing technology during virtual lessons, and on-site at Bowden Academy when possible, the Intensive Intervention staff will incorporate the use of laptops or I Pads, online video conferencing (ZOOM), slide presentations, virtual classrooms, collaborative workspace through hybrid instruction using virtual and in-person instruction as computers, typing software, tablets, Canvas Learning software, Google Classroom, and Seesaw software for first graders. All of these measures ensure that the students have continued intensive intervention reading lessons and ongoing comprehensive support.

Ella Austin Community Center is requesting program support from the Harvey Najim Family Foundation to offset the cost to help low-income, disadvantaged elementary youth in 1st through 3rd-grade students on the East side of San Antonio in order to improve their overall academic performance by increasing their reading proficiency. By meeting the educational and social emotional learning (SEL) needs through educational and supportive services we will provide a pathway to academic success. In addition, we will be meeting our co-investment requirements with the United Way co-sponsorship of the Successful Student Impact Council. The Ella Austin Intensive Reading Program will introduce youth to reading proficiency through virtual classrooms and hybrid instruction so that they may follow a path that leads to academic success, higher education, and a higher quality of life. Our goal is the help children reach their full potential and become adults who make positive and meaningful contributions to their community.

Evaluation Plan:

The Youth Department utilizes the following tools for evaluation purposes: Annual Measurement Metrics Matrix, Comprehensive Annual Program Reports, Measure of Academic Progress (MAP) scores, Fountas and Pannell Developmental Assets Profile, and Parent & Children Impact Surveys.

These tools will be provided to ensure that high quality programs are monitored and evaluated with best practices for grade promotion & graduation, homework support, and school readiness.

Family & Children Demographic Data Sets are provided to describe the characteristics of the population served. This research allows Ella Austin to adjust programming goals to effectively meet the needs of the changing community.

Quantitative Measures: School & Program Attendance and Academic achievement, Fountas & Pinnell Gradient levels, and Measurement of Academic Progress (MAP).

Qualitative Measures: Parent Satisfaction Surveys, Children Satisfaction Surveys, and Parent Engagement Assessment.

Reading Instructors continuously monitor the progress of students and set goals for higher achievement and overall academic growth.

Plans to sustain project beyond the term of this request:

The sustainability plan in place to protect and preserve the longevity of the Ella Austin Intensive Reading Development Program is a multi-faceted plan involving funding from many sources. The plan involves seeking grants from local, state, and federal organizations or corporations dedicated to promoting the success of underserved youth. In addition, soliciting donations from major philanthropic foundations, writing additional grants to secure specific needs of the program, and generating income through fundraising will be implemented. Approximately 15% of the Youth Director's time is devoted to securing community partnerships for in-kind donations of time, talent, and treasure from a wealth of diverse literacy enrichment programs, such as Gemini Ink will be incorporated..

In addition, the project will be sustained by continuing to partner with our longtime funders, including the Harvey Najim Family Foundation, City of San Antonio, San Antonio Area Foundation, USAA, HEB, Charity Ball Association, and Valero.
