# Program / Project Title:

To support financial assistance for fifteen children in the San Antonio area to attend Camp Reynal.

# Harvey E. Najim Family Foundation Priorities:

#### **Program / Project Description:**

Created in 1992, Camp Reynal offers children with kidney disease or a kidney transplant the chance to come together for a traditional camp experience while also enjoying the fellowship of those who know exactly what it means to be a child living with kidney disease. Camp Reynal is provided free of charge to the camper family. It is held annually during the last week of May at Camp John Marc in Meridian, TX. Children, ages 8 to 16 years, are eligible to attend. Unlike the typical summer camp, Reynal is equipped to care for medically fragile children who require daily daily medication, special diets, and medical treatments such as catheter changes or dialysis. In fact, the camp is one of the few in the U.S. to provide on-site dialysis and the only one in Texas. Without the dialysis center, only 50 percent of the campers would be able to attend. The focus at Camp Reynal is less on the challenges of the disease and more on meeting new friends, participating in camp activities, and acquiring socialization and self-care skills. The National Kidney Foundation (NKF) works with a network of medical professionals, child life specialists and social workers at Children's Health Dallas, Cook Children's in Fort Worth, and CHRISTUS Santa Rosa Hospital and University Children's Health in San Antonio to refer patients. Dr. Ray Quigley, a pediatric nephrologist at UT Southwestern Medical Center, is the camp medical director. Activities include horseback riding, archery, swimming, ropes course, fishing, boating, and art. These, paired with group activities such as bonfires, campfire sing-a-longs, nature hikes, star gazing and dance, give children with chronic kidney disease a classic summer camp experience while addressing their specific needs. At camp, children are encouraged to learn more about their health. For example, reading food labels to determine the amount of sodium in food products and playing kidney quiz games are activities that reinforce self-care. Camp Reynal also provides a much-needed respite period for the families of campers. Parents can rest east knowing that their child is safe and receiving care from renal experts. Some families travel two and three times a week to a hospital for dialysis. The break from caregiving responsibilities might allow for a vacation or simply provide an opportunity to spend quality time with other children in the family.

#### **Evaluation Plan:**

Camp Reynal is designed to build self-esteem and increase knowledge about kidney disease. In order to provide annual measurements, NKF surveys the parents, medical staff, and counselors. Medical labs from before and after camp also serve as an important tool for measuring impact. Another measure of Camp Reynal's success is the number of returning campers. More than 90 percent of first-time campers return the next year. More and more campers are even returning in the counselor role, showing their growth and maturity from their time at camp, and choosing to return as mentors for fellow patients.

### Plans to sustain project beyond the term of this request:

Historically, Camp Reynal has had a strong network of supporters. Kidney Texas, Inc has supported Camp Reynal for the last 15 years and has been a primary funder. New funders have also been identified. Rees-Jones Foundation, The Gil and Dody Weaver Foundation, and Crystelle Waggoner Charitable Trust are new donors. NKF will continue to cultivate existing partnerships while seeking out new funding opportunities through grants and sponsorship.
