Program / Project Description:

Over four years ago, we realized that the vehicle fleet of RMI was woefully inadequate. Many of the vans were 10 years old, had 100,000 plus miles, had "multiple drivers", and quite frankly were not maintained to the level of stewardship our participants should be accustomed to receiving. Thus, RMI began its Vehicle Replacement Program. The purpose of this program is to maintain and sustain all RMI vehicles, this includes, but not limited to oil changes, registration, modifications, and overall replacement. All vehicles in the program are purchased in the best condition possible for the best price. This means, we also prioritize the cost of the vehicle.

For the past four years, we have been able to diligently conduct the Vehicle Replacement Program. We are proud to state, of the 18 vehicles in our fleet, we have replaced 11 of the 12 identified as unacceptable. Naturally, over the past 4 years...life happens!..and there have been other transportation issues pop up. Specifically, 2 of our vans were stolen at the beginning of the pandemic in 2020 (talk about adding insult to injury!) However, part of our "Vehicular Replacement Program" addresses sustaining (budgeting replacements) once our base line is established.

Last year, we received help from the Harvey Najim Family Foundation (HNFF) to replace both the Wells Harbor and Puma Pass group home vans. Although 2020 was horrible and our participants were forced to "stay at home" and "shelter in place" for almost an entire year, RMI made every effort to keep their worlds from getting even smaller! It was these vans that saved the day. Each week RMI scheduled specific group home outings tailored to the abilities of each house. Without reliable transportation this would have never been possible. RMI has the HNFF to thank for many of these vans and we remain eternally grateful. Who would have known the HNFF past gifts would have made this possible!

This year, we are requesting help in the continuation of our plan to make initial replacements of our vehicles. We are humbly asking for assistance in purchasing a van for our Boulder Oaks group home. This particular van is over ten years old, has over 100-thousand miles, and is responsible in transporting six disabled ladies.

Evaluation Plan:

Evaluation is in two separate areas, programming and physical use.

These vans will allow for safe and reliable transport to and from community activities, day programs, the grocery store, and more. With our past van purchases, we have seen an increase in community activities as our staff feel more at ease, driving a van that is newer and more reliable. Additionally, project evaluation will be based on specific program objectives for each group home. Providing both our staff and participants with peace of mind and a feeling of safety will allow for more program growth.

We will evaluate the physical use on a monthly basis by tracking mileage, oil changes, and repairs.

Plans to sustain project beyond the term of this request:

We believe in keeping our vehicles in the best condition. We do this by changing the oil every three months, continuous maintenance repairs and checks, and not to mention regular detailed cleanings.

This request is the last of our initial vehicles needed in our Vehicle Replacement Program. As stated, last year we replaced two of the final three vans at our group homes. Although additional vehicles need to be cycled out, as promised at the onset of this program, we have budgeted for these.

In the coming years, once our vehicles have been replaced, RMI will continue to be in the position to budget for annual vehicle replacement and repairs. We are very proud of how far we have come on our vehicle replacement program in the past four years. We honestly would not be as far along if it had not been for the help of the Najim Family Foundation.
