Mission Statement:						

Texas Diaper Bank (TXDB) commits itself to its mission: to address the diaper gap and its impact on low-income families. The diaper gap is the lack of access to an adequate supply of diapers, period products, incontinence items, and other healthcare products impacting the physical health, mental health, and economic well-being of low-income families.

Program / Project Description:

The diaper gap, the lack of access to an adequate diaper supply, directly impacts babies' physical and mental health. In San Antonio, 29% of children come from families living below the poverty line. These families struggle to provide necessities, including diapers. Unfortunately, federally-funded programs do not subsidize diapers. For these families, an illness or job loss can threaten their survival. To meet the needs of low-income families in San Antonio and surrounding counties, TXDB provides access to diapers, wipes, diaper rash cream, and other basic healthcare items. TXDB accomplishes this goal through its Diaper Assistance program, which includes both direct and indirect services.

By March 2020, TXDB tossed aside all carefully laid plans and anticipated accomplishments with the influx of families seeking services as the COVID-19 pandemic spread. It was incredibly stressful for families with babies and toddlers as necessary supplies such as diapers and wipes disappeared from store shelves. Many families living at or below the poverty line were already struggling to afford food and shelter, and as jobs were lost or hours cut back, the situation became dire.

To meet the community's needs, TXDB quickly adapted its delivery model to meet CDC safety guidelines. This reconstruction transitioned in-person operations to a contactless home delivery system. Beginning March 2021, home deliveries will increase to a 3-month supply of diapers, wipes, and other primary healthcare items. The new delivery model eases the organization to provide clients access to healthcare necessities. However, this new distribution model has incurred unexpected transportation-related expenses, including gas, vehicle maintenance, and an additional driver.

To reach more families in need, TXDB partners with 39 "Basic Need" partner agencies and 10 "Supplemental Goods" partners serving Texan families in targeted geographic areas. These agencies provide wrap-around services to the community, with TXDB supplying diapers, wipes, and other distribution items to qualifying agency clients.

The Diaper Assistance program also serves as a conduit for the organization's other programs, including Calm Parent, TXDB's educational component. Included in Calm Parent are classes in baby-proofing the home, diapering, potty training, and self-care for parents.

As Winter Storm Uri blasted Texas, causing power and water outages statewide, TXDB delivered diapers, wipes, incontinence supplies, and period products to San Antonio warming centers. Additionally, TXDB hosted a drive-through distribution and hygiene items such as soaps, shampoos, socks, blankets, and adult and children's winter coats.

As a note, the Diaper Assistance program has substantially grown from last year and assumed many of the organization's noncash supplies, including diapers, wipes, and clothes.

For 2021, TXDB plans to serve 62,300 unduplicated children and distribute 2.3 million diapers in its Diaper Assistance program.

Evaluation Plan:

The organization intently measures program success by evidence-based tools developed by Dr. Teresa Granillo, MSW, Ph.D. These tools include the Family Empowerment Scale, Adult-Adolescent Parenting Inventory for Low Income Population (AAPI) measuring corporal punishment values, and Parenting Stress Index (PSI) factor structure measuring parents and caretakers stress and anxiety.

Plans to sustain project beyond the term of this request:

Before enlivening any program, Texas Diaper Bank carefully deliberates on cost, viability, and impact. Texas Diaper Bank actively sustains all its programs and has never cut any program due to funding. Texas Diaper Bank maintains a cash reserve policy of 3-5 months of operational costs. The organization's revenue streams comprise of donations, federated campaigns, fundraisers, grants, and non-cash contributions.
