Program / Project Description:

Family Endeavors Inc. dba Endeavors Fairweather Family Lodge (FFL) supports single women with disabilities and their children who have experienced chronic homelessness. FFL supports families by providing safe and sustainable housing and voluntary access to supportive services which include: intensive case management, mental health services, food, clothing, childcare, life skills training, employment/educational training, and children's activities. FFL proposes to utilize Najim funding of \$84,098.40 to sustain our Children's Activities Coordinator (CAC) salary and to provide continued supportive services to engage our children aged 0-18 and their mothers. FFL projects to serve up to 25 homeless single mothers with mental illnesses and up to 40 children during the 2020-2021 grant year.

Living in poverty has led our families to experience many adverse conditions which include: hunger and food insecurity, domestic violence, substance abuse, neglect, and not having a stable and suitable place to live. Early childhood stressors and trauma, have had a significant impact on the child's development, causing delays in milestones, and impacts learning in all areas: linguistic, cognitive, and social-emotional. Trauma causes adverse behavior and health, and not being able to sustain supportive relationships. All of these impacts can lead to early dropout rates, teen pregnancies, the continued cycle of abuse and neglect. The FFL program design is based on the theoretical framework of a two-generational model that provides social support and trauma-informed care to assist our families in healing, empower them to create healthy choices and maintain self-sufficiency.

Funding provided by the Najim Charitable Foundation has supported FFL in hiring our CAC who has designed, implemented, and evaluated all activities and services for the children residing at FFL. Our CAC has created the Mighty Munchkins program, held 4 times a week for an hour to assist in development of milestones for children aged 1-5. Each session focuses on different areas that include: sensory, literacy, fine and gross motor skills, and cognitive development. All activities during each session focus on one or more of these areas and offer individualized support. Additionally, our CAC and Parent Educator conduct the Ages and Stages Questionnaire (ASQ-3) for children aged 0-5 to understand how to individually support each child and if needed, refer the child to other community resources such as Early Childhood Intervention (ECI).

Our CAC operates our afterschool program, Power Hour, which has been developed for our school aged children ages 5-18. Our CAC and seasonal interns provide homework assistance and activities that are developed with the inclusion of the 40 developmental assets. These assets encourage our children to gain support from trusted adults, recognize boundaries and expectations, cultivate positive values, inspire a commitment to learning, and develop a positive identity. To encourage additional family support and mentorship, our children receive individualized time for self-expression through one-on-one sessions conducted by our CAC. This opportunity reinforces that our children have allies in the community.

Our program, Play Connection, is conducted weekly by our Parenting Educator (PE) and assisted by our CAC to teach and encourage our families to maintain healthy life-styles and make better choices. Play Connection is designed to strengthen the bond between mothers and their children and to encourage engagement in play. Monthly family field trips are facilitated to develop social and emotional skills in settings outside of our campus and are utilized as incentives for program participation. Field trips offers opportunities for further family engagement which might not be experienced without the financial support of our program. Furthermore, FFL values instilling traditions for our families and celebrates our children's birthdays through monthly celebrations to boost self-confidence.

FFL is an ongoing program that serves a vulnerable population who have experienced homelessness, abuse and neglect. Thus, providing permanent housing and supportive services that can assist our families in healing from trauma is a priority. To assist in healing, FFL offers onsite therapeutic counseling that may be conducted in settings that include: one-on-one, family sessions or through Peer to Peer group. Peer to Peer sessions are held weekly for both our mothers and children.

During 2019, FFL provided over 2,600 hours of direct services to our children and has achieved unprecedented outcomes to include: 100% of children at FFL maintained their educational goals and 100% of families at FFL have increased their engagement in activities and functions. Our goals and values continue to align with those of the Najim Charitable Foundation as we continue the commitment to serving the critical needs of our children and mothers in promotion of growth, success, and self-sufficiency.

Objectives:

oNecessities: Case Manager's (CM's) will create Individualized Service Plans (ISP's) for each family to receive appropriate housing and basic needs by connecting them to community partners. CM's will continuously asses and meet the families' basic needs of clothing, food, medical, dental, and mental health care, and transportation.

oEducation: CM's and CAC will ensure that FFL children are properly prepared for school and will assist with children's school enrollment by helping mothers obtain necessary documentation, transportation, and supplies. Pre-school aged children will be added to Pre-K for SA and Early Head Start waitlists. Additionally, mothers will be assisted with continuing their education through FFL and partnered agencies. Furthermore, families will be offered life-skills training.

oHealing: CM's and CAC will assess mothers and their children's mental health and will connect them to mental health professionals to begin the healing process from traumatic experiences and gain stronger family relationships. CMs will provide additional referrals for parenting education and assistance with benefits.

Evaluation Plan:

FFL will conduct and complete quarterly individualized service plans (ISP) that are client-centered and focused on families reaching goals to sustain self-sufficiency. ISP's are reviewed in bi-annual sessions with the Head of Household and the entire program team. These sessions serve to provide mentorship and support for the family. Staff strengthen their trusted relationships with the families and help understand how to best support them in achieving their goals. Additionally, quarterly assessments and surveys are administered to our mothers to provide program satisfaction, and direction in what services should be offered, along with a Quality of Life Survey. FFL collects, compiles, and reviews the program data to measure our success and impact of our program and the families we support and serve. Outcomes:

- o 100% of families, 25 mothers and 40 children, will receive safe and secure housing, and have their basic needs met.
- o 100% of the children are provided with access to activities intended to further enhance their development. o 100% of mothers and children with therapeutic service goals are connected to experienced mental health care providers.
- o 96% of children are projected to pass to the next grade level.

Plans to sustain project beyond the term of this request:

Endeavors' programs and services are ongoing and continue through demonstrated program achievements, established collaborative program partners, and diverse funding sources. The Fairweather Family Lodge is funded through varying sources that include government grant awards, corporate and private foundation grants, individual donations, program income, and service contract fees. Endeavors' Development Department continuously researches and secures funding and contributions for all of Endeavors programs and projects. In the event we unable to secure funding for the FFL program, Endeavors will fund the difference.
