# Harvey E. Najim Family Foundation Priorities:

Disabilities/Special Needs

## **Program / Project Description:**

Children with special needs call for playgrounds that foster sensory, social, and creative play. It is through play that children learn to engage and interact with the world around them. In order to maximize and stimulate the development of children's social, emotional, cognitive, and physical development, as well as their creativity and imagination, Respite Care of San Antonio (RCSA) recognizes the importance of specialized pieces of equipment. Traditional playgrounds often have uneven surfaces made of pea gravel, mulch or sand. For children with adaptive equipment such as walkers, wheelchairs, or ankle and foot braces, it is not possible to navigate these uneven surfaces under their own power.

The current playground used by the children at the Davidson Respite House (DRH), Najim Respite House (NRH) and the Respite Care Developmental Daycare (RDD) s approximately 20 years old. The rubber surface on the playground, which allows many of the children with physical disabilities to maneuver on their own, has had numerous repairs. The play structures have been worn from use and the elements. Both the playground surface and the play structures have now served well beyond their life expectancy and need to be replaced.

The cost of replacing the playground surface and structures is approximately \$240,000 We have received \$115,000 from the Charity Ball Association to replace the playground surface and \$25,000 from the Andeavor Foundation toward the purchase of playground equipment. Our request to the Najim Family Foundation is for \$60,000 to go toward the purchase of the playground equipment. The new structures will be suitable for children from 2 to 12 years old, with varying levels of ability. The Respite Care Foundation will be asked to fund the remaining costs.

The requested funds will impact 450 unduplicated children annually and approximately 6,750 children over the expected fifteen year lifespan of the equipment. That impact will be significant. A study by UNICEF shows that for every \$1 invested in the physical and cognitive development of babies and toddlers, there is a \$7 return on investment. Therefore, the investment of the Najim Family Foundation will be multiplied as the children mature.

## **Evaluation Plan:**

The project will be considered successful when the existing surface and playground structures have been replaced with a new surface and new playground structures.

### Plans to sustain project beyond the term of this request:

With proper maintenance and care, the life expectancy of the playground surface and equipment is approximately 15 years. Barring any unforeseen major damages, funds needed for the maintenance and/or repairs to the surface or playground equipment will be included as part of Respite Care's annual operating budget.
