Program / Project Description:

We are grateful for the generous support we have received form the Najim Charitable Foundation to support our programs serving children in our Westside community.

The current year has upended many of our plans as we find our organization responding to different, complex, and increasing needs. While we continue to serve our community, we have a delayed date for the completion of our capital campaign renovations. Currently we must focus on keeping our clients safe and helping them respond to new challenges.

Our request is for funding that will help us weather the current pandemic with uninterrupted service to the children in our community. We request funding to assist with the following: tuition for Kid's Place childcare for children whose families cannot pay our full fee, funding to provide Respite scholarships to children whose family environments and finances indicate a great need for our services to be provided free of charge, funds to insure our facilities and the homes of our children remain safe, and the ability to virtually access educational and engaging programming to supplement and replace the "in-person" field trips we would otherwise provide to children enrolled in Peace Pals, our after-school program.

Our Kid's Place Development Center serves children aged 18 months to 5 years of age. We are one of a few childcare centers in the area equipped to provide therapeutic interventions for children and families with special needs. We partner with the Harry Jersig Speech and Hearing Center, we offer speech and hearing evaluations, screening, and intensive behavioral coaching at no cost to families. We work to alleviate any barriers to success and work to make our children ready to enter the school system, prepared to reach their potential.

Peace Pals serves children aged 5-12 and was added to our programs in Fall of 2019. As an after-school program, Peace Pals not only offers a safe place for children to learn and engage in activities not easily accessed at home, we also provide a meal each day they are with us, and also distribute supplemental food boxes for their families. This free program serves children from households with the greatest needs. We are currently operating according to all health guidelines.

The primary zip codes we serve - 78207, 78228, and 78237- consistently have the highest rates of child abuse and neglect in San Antonio. Currently, 85 percent of the families we serve through Kid's Place and Peace Pals earn less than \$15,000 a year and face myriad barriers compounded by the rise in unemployment due to Covid-19. Our Hispanic community also experiences a higher rate of death from Covid-19. Rates for child abuse and neglect are higher than the averages for Bexar County and Texas. Mental health indicators show high levels of depression. These conditions have a deep impact on the young children we serve.

Or community has been on the wrong side of the digital divide and this barrier prevents our children from full participation in online school or other virtual activities. This can create a learning and development gap that will negatively affect our already vulnerable children.

Throughout this time, we have not considered suspending program delivery. We are committed to our history of our 100 years of service to the community and have focused on finding ways to keep the children we serve and their families safe, healthy, and empowered to deal with the new reality they face.

Our operations have called for significant changes to program delivery:

o Slowly increasing enrollment to meet mandated enrollment caps for our Kid's Place Child Development Center

o Transforming our free Peace Pals after school program to a Wi-Fi enabled learning center for students to access for homework and activities

o Providing food boxes to Peace Pals student families who are experiencing additional financial stress due to under- or unemployment

o Purchasing the cleaning and PPE supplies and services needed to keep our program spaces safe for staff and children

o Obtaining new technology, software and hardware to allow for a pivot to non-contact virtual engagement whenever possible

o Incurring additional costs associated with staff working off-site whenever possible

o Providing cleaning supplies to the families of our children so that they may keep their home environment safe. These supplies are often expensive and can, at time, be hard for them to access.

o Accessing virtual activities and programs, many with fees, that can replace the actual field trips our Peace Pals students would be taking. These activities and programs include the arts, science, history and other enrichment content.

Our Kid's Place and Peace Pal programs still adhere to the rigorous testing and evaluation standards we have in place. Our goal is to continue the level of consistent, quality program delivery, regardless of the current situation. Further development of our evaluation protocols and data collection have been a priority so that we may better understand and respond to our children's needs.

As we view the rest of 2020, on into 2021, we see that the many adjustments we are making will yield powerful and lasting strategies, our renovations will be completed, and our uninterrupted service will keep our children on the path to achievement.

Evaluation Plan:

Kid's Place data is collected at intake and six-month intervals; results are evaluated by our Early Intervention Coordinator who oversees the Respite Program, meeting with and assessing referred families. Assessments are done at entry, during and before leaving program.

For child:

1. Ages and Stages Questionnaire-Social Emotional 2 (ASQ-SE2): Measures social/emotional development 2. Behavior Rating Inventory of Executive Functioning-Preschool Version (BRIEF-P): Measures executive functioning processes

3. Daily Executive Functioning Scale: Developed in-house to track daily executive function

For parent:

1. Center for Epidemiological Studies Depression Scale-Revised (CESD-R): Measures depression level

2. Parenting Stress Index-4: Measures stress level

For Peace Pals - data is collected twice yearly; September pretest, May post-test.

Children receive the Development Assets Profile (DAP): Measuring internal strengths and external supports, growth in key areas over time; it's a reliable and valid assessment of the strengths, supports, social and emotional factors essential for success in school and life.

Plans to sustain project beyond the term of this request:

Kid's Place is funded through a diversity of partnerships, including the H-E-B Tournament of Champions, Valero Champions fore Charity, H-E-B Pubic Affairs Department, Sundt Foundation, funds allocated from General Operating grants and individual donations and generous in-kind donations of supplies and food. We also fund the program through tuition fees but have seen a sharp reduction in earned revenue that we will not recover this fiscal year. Kid's Place is funded by the sources above but is a free program and all the more dependent on contributions.
