**Harvey E. Najim Charitable Foundation Priorities:**

**Program / Project Description:**

We are asking for Program Support. Funds will be used for things such as food, clothing, medical supplies, school supplies, incentives, activities, wages, and such. We will be teaching basic life skills but also including things such as ethics. Our program will remove youth from crowded shelters and will decrease their chances of catching CoVid. Youth may come from anywhere in Bexar county or Texas. We will be providing services for hard-to-place male youth ages 14-21, statistically People of Color, who will be aging out of the foster care program.

Our purpose is to teach youth to be self-sufficient and to give back to the community. We work with foster youth aged 14 to 21 with the goal of teaching them how to become successful integrated adults.

We provide shelter, food, hygiene, supervision, education support, case management, and enrichment activities, for foster care youth in the Bexar county area. We are a startup nonprofit whose focus is assisting disadvantaged People of Color in the Bexar county area. Due to the current situation, foster care youths face more challenges than ever before. Without the structure of school and without available foster families, youths are shuffled around at an alarming rate. We feel our mission to assist those youths to becoming successful adults integrated into society will lessen the impact on the social services system as well as prevent crime and future imprisonment.

Statistical data shows a 40% of foster care youth end up homeless and unemployed by age 25. Our differences from current programs include lower staff-to-youth ratios, home versus institutionalized settings and a focus on education and planning for the future. We hope to receive donations to be able to fund our startup successfully and branch out to include multiple houses to assist as many foster care youths as possible.

Our expectation is with youth engaged in activities, the likelihood of engaging in nefarious activities will decrease and they will be more productive citizens. We have received input from the advisory board which consists of former foster care youth. Our advisory board takes special interest in activities as they were not given the opportunities within their own institutional programs which they feel would have benefited them. Unplanned pregnancy, violence and criminal activity were frequently the outcome of an overabundance of down time.

This is a new program. For this particular project, we are looking for funding as required by licensing for the first three months. See sustainability plan for more details.

Our youth will have several activities going on to teach them how to be self sufficient and able to be mature, independent adults. Education first. YEIP wants the youth to focus on education by creating an individualized graduation plan including life skills and on-site discussion groups. Life skills will teach youth the basics like cooking and cleaning, but also will also focus on things like work ethics and healthy relationships. We will offer several small Programs such as an Outdoor, sports, and art therapy. YEIP will offer a variety of hobby activities so that youth have options on things to do in their spare time

Licensing requires that we have proof of funds to support ourselves for the first three months of operation until such time as the reimbursement/stipends being paying us. During month one we will hire and train staff. During month two we will place youth. At the beginning of month three we will bill for month two; at the end of month three we get paid for month two.

**Evaluation Plan:**

We will be using surveys, questionnaires, newsletter submissions, and case management meetings to evaluate the needs and of the youth success of the program. Success for us would be measured by youth having an increase in a variety of activities they show interest in. Success helps keep the youth out of trouble, ensuring a safe environment which prompted the legislation and changes that are following for the foster care programs in Texas. Being able to make choices in your activities is fundamental for growth. A youth with the opportunity for growth in a safe environment is more likely to succeed.

**Plans to sustain project beyond the term of this request:**

Once we become licensed, we will be eligible for a state contract and will begin receiving reimbursements within 60 days.
