### Program / Project Description:

Family Service has offered uninterrupted comprehensive direct services to vulnerable populations for the past 117 years. As nonprofit organizations were deemed essential by the state of Texas at the beginning of the COVID-19 pandemic, we chose to remain fully open and continue services to our clients, and we have continued to do so throughout the entire COVID-19 pandemic. We did this because we knew the needs of our clients were too great for us to halt our services, and that their needs would only increase as the pandemic continued. In fact, our agency has seen a 300% increase in the number of clients served across all Family Service Programs. By remaining open and continuing our services, we continue to actualize our mission of empowering individuals and families to transform their lives and strengthen their communities. Additionally, doing so upholds our 117 year reputation of direct service expertise that strategically guides our programs so that, with community partners, we can equitably, holistically, and collaboratively address our communities' immediate and long-term needs.

One of our existing program-focused initiatives that is now addressing the immediate and long-term COVID-related needs of children and families is Por Los Ninos. This initiative nests under our Parenting Education Program, and services are provided by Promotoras, Certified Health Workers, who work through a community peer-to-peer model to engage children and families. This approach to direct service delivery protects children by intervening in child abuse cases for families with children 0 to 8 years of age, strengthens families, improves parenting skills, and creates healthy parent-child relationships. It is critical that we continue these trauma-informed and culturally appropriate direct services, especially in Bexar County. For the past two years, Bexar County has had the highest rates of child abuse in the State of Texas with more children abused each year in San Antonio than either Dallas or Houston-- in 2018 alone, according to Child Protective Services (CPS), 5,865 children were victims of child abuse and/or neglect in Bexar County and 9 children died due to child abuse. This initiative targets families with initial CPS contact across Bexar County, and specifically, in the three zip codes with the highest child abuse and neglect rates in our community: 78207, 78228 and 78238. With the COVID-19 pandemic raging on, child abuse, neglect, and harm will only continue to rise, perpetuating catastrophic multi-generational harm for children and families.

The Promotora model is effective in reducing and preventing child abuse and family violence by using culturally appropriate methods to support and promote healthy and whole family units. Promotoras are frontline staff who are trusted members of the community they serve, and the Promotoras Model is an internationally recognized evidence-based model for engaging vulnerable, low-income, and at-risk populations. In addition to being trained as Certified Community Health workers, our Promotoras are trained in the utilization of two national curricula: The Nurturing Parenting Curriculum as well as the Family Centered Coaching approach. The Nurturing Parenting Curriculum is designed to provide flexibility to meet the unique needs of various parent categories, including teen parents, single parents, Hispanic parents, parents of special needs children and military parents, etc. The Nurturing Parenting Programs have over 30 years of research effectiveness as a secondary and tertiary child abuse intervention model. The Family Center Coaching approach works with parent(s) and the entire family on their unique needs. Because of this, Por Los Ninos, on behalf of our Parenting Education program, works through a trauma-informed care lens to help parents learn and develop skills for managing both crisis and the everyday challenges of family life. This promotes healthy parent-child relationships, the healthy physical, emotional and cognitive development of children, and family self-sufficiency and resiliency.

One way the Por Los Ninos Initiative prevents and reduces child abuse and family violence is by supporting the comprehensive needs of families, and most specifically, meeting their immediate essential needs. In addition the exacerbating financial and economic insecurity our families are experiencing because of COVID-19, the Department of Family and Protective Services has been closed to families seeking services and support, which has displaced many families seeking services. These families have now turned to Family Service for help. The first step in helping these families is ensuring that their basic essentials are addressed--often, those include diapers, wipes, formula, gas cards, food, and baby bassinets. Once our Por Los Ninos Promotoras secure these basic needs, families then have the emotional capacity to become stable. They then can engage in other Family Service programs so that we can holistically and collaboratively address their long-term health outcomes.

The majority of the families in the Por Los Ninos program are often left with the choice of providing basic essentials like hygiene items, diapers and wipes, cleaning supplies, and food for their families, or paying utilities or other bills. This chronic family stress endangers children and creates long-term negative health outcomes for families. In order to keep children safe, and build resilient and healthy families, their essential needs must be met. Funding for this project will help us meet these immediate needs of children and families by providing basic essentials packets to Por Los Ninos families. This ensures that children will have a be able to live full, healthy lives, and that parents can have the support they need for their for children while working through other Family Service programs to ensure healthy and thriving families.

**Evaluation Plan:**

Family Service consistently achieves the following Por Los Ninos outcomes as measured by pre and post assessments:

Outcome 1: 85% of parents served will have an increase in parenting knowledge and skills.

Outcome 2: 80% of parents served will have a decrease in negative parenting and child rearing attitudes as measured by pre and post Adult Adolescent Parenting Index assessments.

Outcome 3: 99% of families served will have no new incidences of child abuse or neglect as validated by Child Protective Services.

**Plans to sustain project beyond the term of this request:**

Por Los Ninos is an ongoing initiative as part of our Parenting Education's robust direct service delivery. We will sustain Por Los Ninos and our Parenting Education services through ongoing grant support, federal opportunities when available, as well as partnerships and collaborations. Family Service also accepts basic essential donations from donors, corporations, and local businesses, and works to promote the needs of our families through advocacy and community engagement.
