The Reaching towards the Stars Through Technology (RTSTT) program funds will direct students learning opportunities in fifth through eighth grade. These opportunities are based on the innovative use of technology to strengthen knowledge and interest in science, technology, engineering, and mathematics. To achieve this purpose, RSTT will support projects that engage students in technology- rich experiences that will increase awareness and interests, motivate students to pursue appropriate educational pathways, and develop content knowledge and practices that promote critical thinking, reasoning, and communication skills needed for their futures. Technology will be used to increase the students engagement levels and increase the occurrence of student centered tasks. RTSTT will broaden participation of all students, particularly those in underrepresented and undeserved groups in the technology field and related education domains. RTSTT will support 6 types of projects:

- o Math lessons from Khan Academy; Reflex Math in the classroom
- o Science- Assist with Science Fair project, and weekly Science Labs
- o English Language Arts- Assist in drafting of essays; View applicable TedTalks, educational You Tube videos
- o Social Studies Keep up-to-date on Texas, National, International events
- o Library Accelerated Reader program comprehension tests
- o Computer/ IT For Cyber Patriot Usage; assist in learning coding

Evaluation Plan:

Teachers will perform assessments of each students pacing to guide their teaching practices. Curriculum will be evaluated and updated by-yearly and act as a guide for teachers to monitor and drive their instructions. Lesson plans will reflect technology and 21st century skill integration. Each teacher will have access to a 21st Century classroom environment, and will receive training and support to effectively use these technology tools.

Plans to sustain project beyond the term of this request:

Reaching towards the Stars Through Technology's sustainability plan will include purchasing technology support through Geek Squad to provide diagnostic and repair services as well as a protection plan. The school has worked diligently to provide the background support to allow a program like RTSTT to thrive. In 2015 and 2017 an overall assessment was provided to OLPH as a guideline for the status of the overall infrastructure along with any deficiencies. This provided a guideline for risk assessment and a blueprint for the future. In 2020 OLPH upgraded to a 200Mbs fiber line. In 2020 OLPH purchased a Dell Server with MS 2019 operating system(incorporating the latest security measures). A yearly strategy session is held between the Technology Committee and Principal to determine the strategy for the year. With the support of the Najim Foundation we can directly translate these efforts to benefit the students.
