**Harvey E. Najim Family Foundation Priorities:** 

Homelessness

#### **Program / Project Description:**

As we continue to experience the economic impact of COVID-19-related shutdowns, low-income families have been among those hit the hardest by reduced work hours, job losses, and school closures. According to Pew Research Center (2020), about half of all low-income Americans have reported the loss of household jobs or wages due to the pandemic, and only 23% have sufficient emergency funds to get them through the next three months. These alarming statistics have a real-life impact in our communities, and the reality is that many families are one accident, one break-up, one illness, one final act of domestic violence away from homelessness.

At Family Promise of Greater New Braunfels (FPGNB), our goal is simple: to help low-income families achieve and sustain independence. The typical family we serve is composed of a single mother, elementary school-aged child, and toddler. However, our agency is unique in that it is one of the very few shelters that accepts two-parent households, single-father households, and families who have not experienced domestic violence (i.e. families experiencing homelessness due to other reasons such as financial hardship, which can exclude them from other shelter programs).

With this application, we seek funding to serve our shelter guests, graduate families, provide case management, and fund the Drive it Home program. This funding will be used to provide financial relief to those who need it, especially in the form of rental assistance, help with utility bills, repairs to vehicles, and other miscellaneous family needs. Essentially, we aim to help families maintain housing stability during a time of great economic turmoil.

Past years have shown us that the need for such services is essential. In 2018, we had almost 170 referrals from people in need of help. In 2019, 14 of our 50 graduate families reached out for support. We expect this number will be closer to 20 families this year due to COVID-19-related shutdowns, which is an increase of approximately 40%. We expect our case manager's total caseload will increase to approximately 25 families a month.

#### **Evaluation Plan:**

We provide ongoing weekly case management for our shelter guests. This serves two purposes: goal-setting and accountability. This also allows for accurate and timely data collection. If a family is not progressing toward meeting their goals, we are able to accurately track that progress or lack thereof and work with them toward the achievement of their goals. As a requirement to graduate from our shelter program, guests must be working, have safe and reliable transportation, safe and stable childcare, a working realistic budget, and affordable housing. Graduate families continue their case management for a year after they move into their own housing. Our oversight and accountability provided through case management ensures that graduates are maintaining their stability and are not at risk of becoming homeless again.

#### Plans to sustain project beyond the term of this request:

In the past we have received support from the McKenna Foundation to provide case management for our families. Local civic organizations, such as the Downtown Rotary Club has provided some funding for the vehicle repair program. The funding for expenditures on behalf of our families for rental assistance, utility help, medical costs, and other miscellaneous needs comes from our general operating expenses. In order to sustain our programs, FPGNB recently received two grants totaling \$11,500 in support of the increased needs of our guests due to the COVID-19 pandemic. In addition to this, FPGNB relies on foundation support, individual donors, and corporate giving. Our programs will continue to be sustained by ongoing fundraising activities, outreach, and foundation requests.
