Harvey E. Najim Family Foundation Priorities:

Education

Program / Project Description:

There is a discernable disconnect between people and nature. As children and adults spend less and less time outdoors, they fail to appreciate the importance of environmental conservation. The San Antonio Zoo is a living classroom that some students cannot afford to visit without funding help.

Every animal encounter children experience is a chance to teach them about appreciation for wildlife and the global need for conservation to preserve the Earth's resources. In a busy urban world where the wonders of nature may go unnoticed, the San Antonio Zoo serves as the perfect living classroom where children of all ages learn to grow with nature.

We offer an unparalleled opportunity for children to interact with nature and our zoo residents in a way that will instill a love of animals, plants and nature; this will enhance their educational experiences and make them want to return to the zoo again and again.

This grant will serve 2,000 children, and each child is in the Zoo for 3-4 hours during their visit.

School Groups can experience the Zoo in several ways:

- * Docents are in the Zoo during the school year, offering a variety of presentations to all Zoo guests.
- * There may be animal presentations with a chance to see an animal up close, as well as "carts" with some in depth information about animals and conservation issues. Carts include bio-facts (feathers, egg shells, bones) or other props and encourage the audience to be engaged in an activity or touch opportunity.
- * Animal Chats and Education Encounters are scheduled throughout the day (times and locations are posted at the zoo Entrance) for all guests to visit at the leisure. These are led by either animal care specialist or educators and include information about the Zoo's animals, natural history facts and conservation messaging.
- * There are graphics in front of all of the exhibits, as well as along pathways and fence lines. I can think of one graphic, that happens to be interactive, that depicts the layers of the rain forest habitats and invites guests to 'lift the flap' to find out what lives in the forest layers. Other graphics address conservation issues and concerns, projects the Zoo supports, and biodiversity.

Children can figuratively travel the world in one day! Although their time at the Zoo is short, one animal encounter that sparks a child's imagination can lead to a lifetime of love for nature.

The Title 1 School Group program is available only to schools located in a Title 1 school district. A Title 1 school district is where a high number or high percentages of children are from low-income families. Each Title 1 school district in San Antonio has similar demographics, all of them overwhelming: 93.4% are economically disadvantaged, 19.1% have limited English proficiency, and 71.7% are classified by the school distract as at risk (San Antonio Independent School District, 2014 2015 District Improvement Plan). In addition, according to the latest information available from the Texas Education Agency, Region 20-71% are Hispanic.

Evaluation Plan:

As this program involves one visit to the zoo-the long-term impact of that visit is difficult to measure. Teachers bring their classes to the Zoo year after year, indicating that they feel there is educational value to this experience.

Success for all of our educational programs is measured by the quality of the experience that was provided the students. Information and feedback gathered from teachers, parents, and students are used to plan the following year's school group program. The zoo works to ensure that its education programs meet the needs of participants.

Plans to sustain project beyond the term of this request:

The general operations of our organization are sustained through earned income, fundraising activities and corporate/foundation grants. Our full-time staff is employed at a steady state, with part-time staff being employed seasonally. Our staff is always available to assist with the Title 1 School Group program. However, sustainability for this program is strictly through corporate and foundation grant funding. If we do not raise the funds, we are unable to accommodate requests for a visit. We do charge a reduced rate for Title 1 School Group visits--\$5.00 per child versus the normal rate of school group rate for non-Title 1 schools of \$9.50 and the regular gate rate for children of \$11.25.

In 2017, 76% of our 66-member board contributed a total of \$3,581,166.99 to the zoo, underscoring their commitment to our mission. Of those gifts, 3,258,583.34 were restricted gifts for Zoo School, and \$322,583.35 were for zoo operations. We routinely host close to 50 % of Board members in attendance at our quarterly meetings. Board members who are not in attendance are provided with meeting minutes and all appropriate materials from the missed meeting. We always have a quorum. Our Board is involved in strategic planning and will have a major role in the approval of the Master Plan for the zoo. The Board also participates in, and invites guests who are potential future donors to, events hosted at the zoo. The board is aware of the programs and program evaluations that are done, however, they have little direct participation in the development of those programs.
