### Program / Project Description:

The Epilepsy Foundation Central & South Texas (EFCST) is a 501(c)(3) health agency and 1 of 48 National Epilepsy Foundation affiliates. EFCST was founded in 1993 to improve the quality of life of the nearly 160,000 persons with epilepsy residing in 79 Central and South Texas counties. As the only organization dedicated to the health and welfare of individuals with epilepsy living in these areas, EFCST serves as a lifeline for the epilepsy community.

EFCST respectfully requests \$36,000 to provide 30 children with epilepsy in Bexar County and surrounding areas the opportunity to attend Camp Brainstorm 2021. Camp Brainstorm is a five-day, four-night residential summer camp at Camp Aranzazu in Rockport, TX for children aged 8-17 with epilepsy. Families of children with epilepsy spend tens of thousands of dollars on medications and medical treatments each year, which is why camp is provided to every family at NO COST. EFCST relies on support from community partners and other private and corporate gifts to send children to camp. The per-child cost is \$1,200 and includes lodging accommodations, meals, program activities, materials, supplies, equipment, and transportation to camp. Funds provided by The Najim Charitable Foundation will not be used for staff or administrative expenses.

Epilepsy is a chronic disease of the brain that causes seizures, and it is the most common pediatric neurological condition. Children with seizures suffer from psychiatric disorders like anxiety and depression at three times the rate of children with other chronic illnesses and five times that of the general population (Epilepsy Foundation, 2014). The unpredictable consequences of living with a serious medical condition are amplified by the social stigma placed upon epilepsy. Common misconceptions about epilepsy, like the idea that it is contagious, lead to children being bullied and ostracized by their classmates. School staff, while well-intentioned, often add to this by not allowing students with epilepsy to participate in certain recreational activities for fear that the child will be injured if they have a seizure.

The effects of social isolation at this critical developmental stage are staggering. It leads to low self-esteem, negative self-perception, increased stress, anxiety and depression, poor sleep quality, and even negatively affects cardiovascular and immune function. This already vulnerable population is now suffering further as a result of the pandemic. Over the last year, mental health-related emergency department visits for children aged 5-11 years increased by 24% and by 31% for children aged 12-17 years (Rebecca T. Leeb, et al., 2020). COVID-19-related stressors include disrupted schedules, decreased social interactions with friends and family, and loss of perceived security and safety.

Camp Brainstorm was created in 2012 to address the immense social isolation experienced by children with epilepsy and has had great success in improving mental health and quality of life in campers. Lisa, a parent of a 2019 camper, said of her daughter's experience at Camp Brainstorm, "She would cry wondering why she had to be different. Camp helped her see she was not that different after all... It was an experience for her soul... For my daughter, it completely changed the way she thinks about herself and her abilities." The importance of camp for our campers truly cannot be overstated.

The cherished moments and memories created at camp made canceling Camp Brainstorm 2020 devastating to both children and parents. While EFCST quickly mobilized to create and implement a virtual camp - which had high attendance and retention rates, indicating a passion for the program by the campers - the loss of an in-person program heavily affected the campers. Returning campers missed out on seeing friends made in years past. First-time campers did not get to feel the relief of meeting other youth with epilepsy and finally gaining acceptance by their peers. For many campers, this is their only opportunity to participate in recreational activities. Camp offers canoeing, zip-lining, archery, and sailing - activities that schools and other programs exclude children with seizures from participating in due to the false belief that experiences like these are not safe for them.

Due to the unremitting financial impact created by COVID-19, the certainty of Camp Brainstorm 2021 is at great peril. Typically, by this time of the year, EFCST has raised the funds necessary to meet Camp Brainstorm expenses. This year with camp only 15 weeks away, these funds have not yet been secured. After having their worlds turned upside down, Camp Brainstorm is needed now more than ever before.

Camp Brainstorm can make a lifelong impact on children with epilepsy through its utilization of recreational, social, educational, and developmental activities. Campers' progress is exhibited by the following outcomes:

Improved Self-Worth - indicated by improved self-esteem, self-image, self-efficacy, self-sufficiency, critical thinking skills, problem-solving skills, perceived confidence, and positive personal growth.

Improved Quality of Life - indicated by the development of friendships, gained independence, improved teamwork and responsibility, improved ability to reduce stress and improve physical and mental health, as well as the development of social skills, creative skills, and positive peer to peer interactions.

Improved Knowledge - indicated by an increased understanding of developmental concepts and methods for conflict resolution, emotional wellness, and time management.

Camp offers the children a unique opportunity to reduce social isolation and loneliness while improving the ability to cope with and manage their seizures and mental health. The long-lasting impact camp has on these children is priceless for them and their families. Five days at camp can be a transformational experience with lasting impact.

#### **Evaluation Plan:**

Surveys and anecdotal notes will be used for process and outcome evaluations of Camp Brainstorm.

Prior to camp, campers and parents will be asked to complete a survey to collect demographic data that will measure camper's epilepsy self-management skills and emotional and mental health wellness.

While at camp, data is collected through conversations and observations. If necessary, adjustments are made in real-time to ensure a successful camper experience. A post-camp survey will be collected to assess changes in self-worth, quality of life, knowledge, and overall program satisfaction. A comparative pre- and post-camp report will be evaluated by the EFCST staff and medical team. This report will be provided to the funder.

To determine the long-term impact of Camp Brainstorm, EFCST staff will perform parent and child check-ins at months 1, 6, and 9 post-camp. Additional anecdotal data will be collected at other EFCST youth programs regularly attended by campers.

#### **Plans to sustain project beyond the term of this request:**

2021 will be the TENTH year of Camp Brainstorm! Each year, campers anxiously await the comradery and shared delight that camp brings. High attendance and retention rates, including virtual camp in 2020, show the love the children and their parents have for this program. The community support and enthusiasm for Camp Brainstorm is just as high, evidenced by repeat donors and diversified gifts from a wide range of funders.

Though camp is free for all families, many provide financial support through contributions to EFCST fundraisers, monthly donations, and their own fundraising campaigns to ensure camp continues. The families' continued outreach and support are instrumental to Camp Brainstorm's success.

To ensure sustainability, EFCST is continuously seeking new funding sources and improving its marketing, implementation, and evaluation methods for Camp Brainstorm. Our long-term partnership with Camp Aranzazu and their dedication to the camping program offers an unforgettable experience for these precious children.
