Program / Project Description:

Autism spectrum disorder (ASD) is a disorder of development characterized by differences in social interaction, communication, and abnormal behavior patterns. Due to the nature of the disorder, it is critical to diagnose children early for the best chance of success. Children diagnosed by the age of three years, six months have a 50% chance of entering kindergarten with their same aged peers, while children diagnosed after that age have only a 10% chance (The National Academic Press, 2001).

Autism Community Network (ACN) is a non-profit agency working on behalf of children and families for whom autism spectrum disorder (ASD) is either suspected, or medically diagnosed, in Bexar and surrounding counties. ACN was founded in 2008 by a consortium of health care funders concerned with the growing prevalence of ASD and the lack of developmental services in our area to address the increase in incidence rates. Of particular concern were families challenged by obstacles to quality health care, putting them in greater danger of misdiagnosis or late diagnosis.

Over the last 12 years, ACN has served over 20,000 individuals and diagnosed over 7,000 children. A committed staff of 17 individuals is changing lives of families affected by ASD. ACN's 9 clinicians have a combined 183 years of relevant experience offering this community the most expert and comprehensive approach to medical diagnostics, therapeutic intervention, effective caregiver training.

ACN offers:

- -Medical diagnostic services for children,
- -Occupational, speech, and behavior therapy for children,
- -Classes, hands-on courses, and online resources for caregivers,
- -Caregiver wellness monitoring,
- -Professional development for professionals serving children with autism,
- -Summer camps for children, and
- -Community outreach and awareness.

In April, 2020 The Centers for Disease Control and Prevention (CDC) released a new incidence rate of autism of 1 in 54. At the local level, a report commissioned by the Kronkosky Foundation in 2016 found 1 in 81 individuals in Bexar County is diagnosed with ASD. The rate of autism has continued to grow since ACN's inception in 2008, yet the services available in our area are unable to keep pace with the demand. ACN provides medical autism diagnostic services to families who have limited options. ACN is currently one of two agencies serving the Medicaid population, in Bexar County and surrounding counties, with clinical diagnostic services. ACN's current wait list is an average of 14 months from initial referral to diagnostic appointment. This is currently the shortest wait list in the city and far from ideal.

ACN is committed to the following objectives for the 2021 fiscal year:

Objective 1: Provide high quality and autism diagnostic services to under-served children and families. It is our goal to schedule 900 diagnostic appointments and provide a minimum of 750 unduplicated services for children. The expected outcomes are children who are diagnosed earlier will have greater opportunities for future success in the school setting and a reduced life-time cost of health care. Every family will be surveyed for satisfaction with diagnostic services provided. Additionally, families will register for Autism Lifeline Links (ALL) at the time they are asked back for a full diagnostic evaluation. This information is collected by the Chief Operating Officer and analyzed on a monthly basis.

Objective 2: Provide high quality, best-practices education and intervention for children with autism, autism service providers, and families of children with autism. It is our goal to serve 1,250 through this effort. Outcomes include: improved systems dynamics due to increased awareness, education and knowledge; improvement in interactions between caregiver and diagnosed child; increased appropriate caregiver responses to diagnosed child; and increased functional and social-emotional capacities between parent and child. Additionally, ACN will provide high quality, best-practice intensive, parent-mediated therapies for families of children with autism, high quality, best-practice, strengths-based camp experiences for children with autism, and continued care coordination through a behavioral health integration follow-along program for families of children with autism. The Chief Operating Officer collects this data and analyzes it monthly.

Objective 3: ACN will cultivate a high level of awareness of autism in the San Antonio area by creating online event and services (for the forseeable future) for families that are safe for children and allow parents/caregivers to connect and generate opportunities for enhanced programming and service delivery through collaborations and partnerships in the community. Expected outcomes are: increased awareness about autism within the community at large, a sense of relief among families who often feel isolated and overwhelmed, and efficient connection of services among organizations who work with the same population. This information is gathered by the Chief Development and Outreach Officer and analyzed on a bi-monthly basis.

ACN respectfully request \$55,000 from The Najim Family Foundation to be directed towards professional salary expenses. \$52,000 of granted funds would be used to offset the payroll costs of ACN's developmental behavioral pediatrician and \$3,000 would be used for direct assistance.

Evaluation Plan:

Quantitative goals related to number of clients served will be tracked through the clinic database monthly, and shared by the Executive Director with the Board of Directors, ACN staff, funders and the public. The quality of diagnostic services will be analyzed by Family Satisfaction Surveys, administered after every diagnostic appointment. These surveys are reviewed by clinic staff and leadership staff and shared with the Board of Directors and key stake holders in monthly and annual reports. Survey results are transferred into numeric data and stored in the clinic database, along with any additional comments the family might make.

Plans to sustain project beyond the term of this request:

Plans to sustain this program include seeking funding from corporations, foundations, individual donors, and annual fundraising events. ACN intends to partially sustain this program through earned revenue from third party payers. Over the last 12 months, ACN has continued to updated procedures by which we bill third party payers, negotiate contracts, and submit claims. We have secured all commercial and Medicaid insurances, contracted as a group and as individual providers, in order to capture the best reimbursement for each planner. ACN's budgeted earned revenue has increased from 8% to 18%. Program fees are the earned revenue we receive from insurance reimbursement for our patients. In 2018, 72.8% of patients seen for screenings were Medicaid qualified. Though return on Medicaid collections are typically lower than private insurance, we are secure in the fact that we file claims for a large number of patients.
