**Program / Project Description:**

Wonders & Worries opened in 2001 in Austin after our co-founder, a child life specialist working in a public hospital, met parents who were facing a serious illness, but who faced uncertainty about what to tell their children. Their worries reflected a gap in healthcare services that Wonders & Worries was created to fill.

Since its founding, Wonders & Worries has impacted the lives of 10,000 individuals and 2,600 families, now providing comprehensive services to families in Central Texas, Greater San Antonio, and Houston.

Our San Antonio location opened in 2017 when The Children's Bereavement Center of South Texas (CBCST) contracted us to provide therapeutic support to San Antonio families affected by serious parental illness. Requests for our services quickly grew, and we became an independent nonprofit here in early 2020. A grant from the Najim Family Foundation helped us establish a foundation for growth, making it possible for us to serve 205 Greater San Antonio residents last year.

This year, we ask the Najim Family Foundation to consider renewing its \$25,000 grant for our evidence-based Illness Education and Coping Support program in San Antonio. Data from the Texas Cancer Registry, along with nationwide cancer statistics, show us that an estimated 1,500 Bexar County families will face a cancer diagnosis by the end of this year. In addition to providing services for parents or caregivers with cancer (80% of our client families), Wonders & Worries also serves parents diagnosed with other illnesses such as heart disease, diabetes, and ALS. Your grant would help us continue to provide services at no cost to families, a critical factor during these financially challenging times.

Families begin their journey with Wonders & Worries with an intake session. Depending on the family's needs, the child attends individual or group sessions led by a child life specialist, a healthcare professional who is trained to help children and their families understand and manage stressful health care experiences. Child life specialists customize the sessions by incorporating games, crafts, and other activities to help the child understand the parent's illness and learn to constructively process emotions. The sessions are held once per week for six weeks. Services are provided in English or Spanish.

Normally, sessions are conducted face-to-face in our office at the START Center for Cancer Care. The COVID-19 pandemic altered our daily operations, requiring us to modify the curriculum activities so that they could be delivered virtually through our communications platform, RingCentral. Supply kits are mailed to families who need them. After the sessions conclude, children have the option to participate virtually in group check-in sessions.

For families with younger children (ages 2-4) or those who do not have a computer, smartphone, or internet access, the child life specialist consults with the parent over the phone, and the parent facilitates the session. After the session, the child life specialist follows up to provide any additional guidance. For bereaved children who have lost their parent during their time with us and who request on-going grief support, we work in-tandem with the CBCST to gradually transition them from our services to theirs.

Until the pandemic is under control, we will continue to operate virtually, with a few exceptions. Most families we serve are immunocompromised with at least one parent who faces health-related complications if exposed to COVID-19. When we can ensure the safety of our client families and our staff, we will reopen. We anticipate that we will continue to primarily provide telehealth sessions until the end of the summer/beginning of fall.

When we reopen, we will continue to offer telehealth sessions as an option for families. We have found that some families prefer telehealth sessions, especially those who live far from the START Center, because virtual appointments remove transportation barriers, and they provide the convenience of attending the session from the comfort of the family's home.

In the year of your grant, we anticipate providing approximately 900 therapeutic sessions and consultations for 226 individuals in Greater San Antonio. By participating in our six-session Illness Education and Coping program, children and teens can expect to gain:

- 1) Age-appropriate understanding of illness, treatments and side effects;
- 2) Strategies for identifying and expressing feelings related to changes in the family;
- 3) Skills for coping with stress, anger, sadness and fear; and
- 4) Connections to peers sharing similar experiences.

Their child life specialist works with them to provide the behavioral health support that they need to prevent psychosocial problems such as "anxiety, confusion, sadness, anger and feelings of uncertainty". Professional support is necessary to help children navigate the trauma of their parent's serious illness (F. Phillips, 2016, Psycho-Oncology). As Amy McGeady, former Wonders & Worries Board President notes, "I wish that this service had existed during my childhood, when my mother had ovarian cancer in the 1980s. I've spent many years healing the emotional scars of that time."

Because a parent's serious illness has a negative effect on a family's income, Wonders & Worries is committed to providing our services free-of-charge. This is even more important now considering the devastating economic impact of the pandemic, particularly in communities of color. With the continued support of the Najim Family Foundation, we can ensure that we can reach families throughout Bexar County during the pandemic and beyond.

**Evaluation Plan:**

Internally, to measure the success of our Illness Education and Coping program, we distribute electronic surveys (email and text) twice per year to parents or caregivers whose children have completed the program at least three months ago. Surveys are in Spanish and English. Success is reached when 80% or more of survey respondents show improvements in their ability to parent around the illness; their ability to manage stress; and their overall satisfaction. We also anticipate that at least 70% of survey respondents will report that the anxiety of their child has been reduced after receiving services.

Initial results from our most recent survey, distributed in February, are promising. This is the first group of clients surveyed who have only been able to receive virtual services. They all started the program after the pandemic started. The results indicate that, overall, the telehealth sessions are as effective for families as face-to-face sessions.

**Plans to sustain project beyond the term of this request:**

Wonders & Worries has a comprehensive development plan which provides a diversified, stable, and sustaining source of revenue. Through this diversification, we provide opportunities for donors to contribute in a variety of ways and giving levels. Our development plan includes a planned giving program, an endowment, monthly giving options, grants, and corporate sponsorships. Further, we have launched programs that generate revenue from non-traditional fundraising sources, such as our Registered Wonders & Worries Provider program, a training program whereby professionals pay a reoccurring fee to deliver the Wonders & Worries curriculum in their community.

This year, like many other nonprofits, our fundraising events were impacted by COVID-19. To offset these losses, we received a PPP loan in the summer and applied for another one in January. We also received several COVID-19 relief grants, and we ran specific COVID-19-relief campaigns. Although we were unable to host in-person fundraising events in San Antonio this past year, we anticipate that we will host one in the fall and one next spring.
