Wish Granting / Adopt-A-Wish

When a child is diagnosed with a critical illness, only one thing is sure: life will never be the same. Hospital stays, doctor's visits, and treatments disrupt all that feels normal for the child and for loved ones. Families' resilience and resources are stretched for years. Now more than ever, the hope of a wish come true is needed.

While medical treatment is both miraculous and excruciating, children must build the mental resiliency necessary to continue treatment. Each wish begins when a medical professional or parent refers a child, between ages 2 1/2 years and before their 18th birthday. Once deemed medically eligible, an interview with the child is scheduled to ask empowering questions ,like: "If you could meet anyone, be anything, have anything, or go anywhere, what would it be?". After the wish is identified the Program team works to create a magical, individualized, life changing experience for the child.

From the moment a child recognizes the possibility of a wish, "emotion hormones" (e.g. serotonin, adrenaline, cortisol) come into play, which positively affect the child's outlook, revitalizes them and their mental health. **Research conducted by Dr. Mifano Shoshani in 2016, "The effects of the Make a Wish intervention on psychiatric symptoms and health-related quality of life of children with cancer" confirms that a wish experience not only brings more joy to critically ill children, but also an edge in conquering their illnesses.

The visualization, planning, anticipation, experience, and memory allows children to become the hero in their own story, as well as their family's narrative.

The Wish Granting program potentially prevents unnecessary, prolonged treatments. **Dr. Anup Patel's "Impact of a Make-A-Wish experience on healthcare utilization" concluded that the Wish Granting program not only affords children quality of life relief, but also can help reduce the number of hospital visits and healthcare expenditures. By decreasing the amount of time in the hospital, children actualize change in their future, something they conceived themselves. Complimentary, a reduction in treatments has financial benefits to both the hospital and the children's families.

The impact of the COVID-19 pandemic has been a shock to our wish kids, current operations, and chapter revenue. Your continued support will be instrumental in helping us continue to grant non-travel wishes, and to allow us to grant all wish types as fast as possible when the advisory is lifted. Our wish referral pipeline is growing as we continue to re-sequence wishes due to the pandemic and increasing need. Due to travel restrictions, we have had to reimagine wish delivery. Make-A-Wish has and remains committed to finding creative ways to grant wishes, with a focus on every child's safety first - which means an unprecedented level of support is needed to ensure our mission continues We have put 173 travel wishes on hold with hopes of opening travel by car (within 1,000 miles) this summer and domestic travel by January 2022.

Since 1984, our chapter has granted more than 5,000 wishes and we are proud of our over 37 year tradition of never denying a heartfelt wish to a medically qualified child. We are requesting support from the Najim Foundation to adopt 10 wishes. This support is needed to fulfill non travel wishes and postponed wishes as soon as it is safe to do so. We do not want any child to unnecessarily wait even a day. Timing of wishes is of the essence, as research shows children are most powerfully impacted if they are able to imagine, plan, and realize their wish during treatment. With new hope and strength from a wish and a large community of support, more than 70% of Make-A-Wish children survive their critical illness.

Every child deserves a childhood, and we believe our mission gives a piece of it back. With your help, we can prepare now to make the stars align for wish kids who need it most. A wish not only creates hope, but the experience can put children in a better place to cope with and look beyond their illness. Your support will help our children dream about something that may seem out of reach, unattainable. It encourages the belief in making the impossible... possible. Together, we can shine a light of hope joy to children in their darkest days, bringing them strength for tomorrow.

* NOTES:

We serve children with critical illnesses in all City Council Districts, and do not track which district the majority of our wish children live in.

However, all 10 children adopted by the 2020 grant live in the city of San Antonio, and the zip codes represented are:

78251, 78218, 78254, 78264, 78223 (2 children), 78244, 78210, 78207 and 78221.

We are not a designated United Way charity; however, in FY20 we received \$4,724 from the United Way and in FY21 to date we have received \$13,256.

Evaluation Plan:

Make-A-Wish uses a participant post-wish survey, one week after wish completion, to measure process and outcomes resulting from the wish experience. It includes questions about: planning process, communications, appropriateness of information, event preparedness, activities in fulfilling the wish, family bonding, mental and/or health changes due to wish experience, suggestions for improvement, and the overall experience for families. Output and outcome measures reported are used to evaluate effectiveness during the proposed program period. Additionally, disease incidence data is used to estimate number of new eligible children in a given year to ensure we are working toward our vision of granting the wish of every eligible child. We also monitor the number of wishes moving through our "pipeline" and the time taken to fulfill them.

Sample Evaluation Outcome:

90% of parents indicated that the wish helped their child build emotional and/or physical strength to fight their illness.

Plans to sustain project beyond the term of this request:

We've continued to grant wishes to medically qualified children during COVID. Our CEO serves on the national MAW COVID Reemergence Task Force converting nationally to online wish granting and fundraising systems, upgrading socio-emotional power of our process, and centralizing services. Our team pivoted to resource at-home wishes through in-kind partnerships. Our boards, currently led by wish parents and a past wish child, have excelled in asking our major donors for more support by sharing their genuine and impactful experience.

We continue to seek funding from individuals, corporations, national partners, foundations and have 2 internal events: Over the Edge (June) and A Night of Wishes Gala (August); and various external fundraising campaigns. Despite revenue declines in corporate funding due to the impact of Covid, we've grown direct public support by 20% and continue finding ways to engage and connect our donors to our mission.
