Program / Project Description:

There are approximately 50,000 Texas children in the foster care system. A child removed from their home into State custody loses everything they know; their home, parents, friends, school and other connections that provide a "normal" and stable childhood, with opportunities for growth into successful adolescence and adulthood. If a child's parent(s) are unable to rehabilitate the issues that brought the child into foster care, the parent(s) rights are subject to termination by the state. Those children are then in long-term foster care, and become completely disconnected from their home and family communities.

In 1977, Seattle court judge David Soukup conceived the idea of CASA (court appointed special advocates) as he was presiding over child protection cases; he realized the weighty responsibility of the decisions he was making for children and felt he needed an unbiased, unrelated person to make independent investigation into the case, and report to him recommendations in the child's best interest. Soukup's idea grew into a nationwide movement and Hill Country CASA was established in 1989 to provide trained community volunteers to serve child residents of Kerr, Kendall, Bandera and Gillespie Counties in State custody due to abuse or neglect in their homes, and the courts making decisions about their permanence.

Today, our CASA volunteers work under Guardian Ad Litem (GAL) appointment to assure every child receives individual attention, necessary services and timely placement in a safe, loving and permanent home. CASAs are trained to provide strong advocacy for the child's best interest, timely individual services, and family reunification whenever safely and securely possible.

The value of our program is based on common sense of consistent and caring individuals providing strong advocacy on behalf of the children they serve. We are able to achieve this by providing a personal advocate for each case that comes into the Child Protection Courts, and assisting the volunteers to provide the best advocacy possible for every child. Achieving this goal requires well-versed staff, individual support to volunteers, and training that addresses the needs of the children we are serving in Bandera, Kerr and Kendall Counties. Last year, our volunteers gave 3,548 hours and traveled 43,245 miles to child visits, court hearings, collaborative meetings and other events as necessary to provide strong, effective advocacy for children on our caseload.

Hill Country CASA's long established goal is to provide a well-trained CASA for every child in CPS custody in our four county service area, who will conduct an independent investigation into the circumstances of the case and make oral and written report to the presiding judiciary with best interest recommendations for the children involved. Serving 100% of the children from our service area that have been taken into CPS custody because of abuse/neglect will be achievable only if we are able to continue recruiting and training community volunteers to serve as advocates and we give those advocates the supervision and support they need to do their job. As we strive to maintain our service to 100% of children through service of 100% volunteers, we understand that providing support resources to ensure the strength and urgency of their advocacy is paramount to achievement of our programmatic goals. To that end, HCCASA staff work to:

- provide a CASA-GAL volunteer for every child or sibling group that comes before the courts due to abuse or neglect in our service area
- provide supportive, knowledgeable case supervision that develops volunteers into strong advocates urgently pursuing permanency for children
- provide high-quality volunteer training that addresses issues facing our children and families, and provides steps to resolution
- collaborate with community partners, stakeholders and service agencies to promote healing and healthy future development
- raise awareness about the issue of child abuse and to invite citizen involvement in solving this community problem
- advocate for services for Texas foster children as appropriate at local, regional, state and national levels

Hill Country CASA's other primary goal is to reunify children with their natural parents whenever possible; to this end we also provide help and support to parents working toward this goal. Typically, the reason children are in foster care is not due to a lack of love from their parents, rather a lack of ability to safely parent. This may be due to mental health issues, addiction, family violence, criminal issues or other struggles. HCCASA provides a listening ear to parents, models appropriate parent-child interaction, and supports parents as they work toward reunification of their family.

If reunification cannot be achieved, the CASA will remain alongside the child until permanence in a safe, loving home is found. This includes diligent searches for relatives or other kin, follow up with parents, coordinating services and skill building for children, and being a consistent caring adult in the life of the children.

Texas has 72 independent CASA programs that served 58% of the total children in foster care in 2020. Hill Country CASA has been able to provide an advocate for every child in our four county service area for the last 21 years. As Texas CPS faces overarching, court-ordered and legislatively-backed reform, the need for one CASA volunteer to serve a child (or sibling group) is even more important than ever - without the individual oversight provided by CASAs, many children would be lost in the "system" and left to age out of foster care at 18 with few possessions, skills and opportunities to call their own.

Evaluation Plan:

In 1997, Hill Country CASA started annual written program evaluations. Each year we send our annual program evaluation to our volunteers, attorneys ad litem and the judiciary to seek input on our program's strengths and weaknesses. HCCASA's Board aggressively encourages program development and, if program weaknesses are identified, guidelines are set to address the problems. We're pleased to share that we received excellent feedback on the 2020 evaluation from over 95% of respondents. We are aware of the responsibilities that CASA programs have to provide service to the courts, and are grateful for the community volunteers who give their time and energy to Hill Country CASA, and regular scrutinization of our practices and procedures is necessary to ensure we continue to provide good service to our stakeholders.

Plans to sustain project beyond the term of this request:

We receive pass through funds from federal and state government through Victims of Crime Act and Crime Victims Compensation. We also receive state grant through Office of the Attorney General. For the remaining portion of our operating budget, we rely upon the generosity of organizations, agencies and private foundations whose funding priorities align with our own. Annually, we develop a budget and funding plan, and are working to diversify our funding sources - both to ensure steady 100% service to Hill Country children in foster care who have little other resources available to them, and to reduce our dependence on government grants to provide this life-changing service to our communities.
