Program / Project Description:

Funding received from the Najim Charitable Foundation will be utilized for general operating support of SA Youth's two educational programs that focus on academic achievement, developing positive character and behavior, and encouraging physical activities and nutrition education for youth that come from low-income families and are at-risk of academic failure.

Our Out-of-School Time program operates 11 after-school sites, within South San Antonio ISD and San Antonio ISD that serve at-risk elementary and middle school-aged children and their families during the critical after-school hours and over the summer. Our site locations are strategically located in high-need, low-income neighborhoods, serving schools with high percentages of disadvantaged students.

Additionally, our YouthBuild program, a nationally-affiliated youth workforce program, provides young adults between the ages of 16 to 24 a second opportunity to earn a high school diploma while planning for their next steps. This alternative education program is designed to build competitive occupational skills leveraged against the economy of tomorrow and assist students in entering a competitive employment market, enrolling in higher education, and/or enrolling in military service.

The students and families we serve are experiencing unforeseen learning barriers, such as increased back-to-school costs, a lack of necessary technology, and additional safety requirements, including the use of personal protective equipment for in-person learning. Funds from the Najim Charitable Foundation will enable program staff to assist participating students as they recover from the COVID slide, a phenomenon identified by experts, showing patterns of academic setbacks during the COVID global pandemic. Early estimates suggest that students will return this fall with roughly 50% of math learning gains, relative to a typical school year (NWEA, April 2020).

At the beginning of this school year, in coordination with participating school districts, SA Youth programs are providing services through an online, virtual format, due to the COVID-19 global pandemic. The requested funds will allow SA Youth programs to foster an inclusive and stimulating environment where students are continuously engaged in daily curriculum including STEM activities, enrichment activities, positive constructive character-building activities, physical activities, homework assistance, and good study habit tools, all through a virtual platform. Students receive social-emotional based learning with familiar adults, including critical tutoring time. These funds will also enable program staff to reduce learning gaps seen in participating students with increased use of technology and educational software for virtual learning. Students are completing collaborative projects and have the unique opportunity to experience a virtual extended learning day while learning at home.

Funds requested from the Najim Charitable Foundation will enable our YouthBuild program staff to provide high school diploma recovery services virtually and reduce extended learning gaps for our Fall Class of 2020 and Spring Class of 2021. The young adults in our YouthBuild program this year are receiving virtual small group instruction and one-to-one tutoring, if needed, through video conferencing, as well as consistent social-emotional support from familiar SA Youth staff.

SA Youth program staff is committed to promoting healthy lifestyles as part of its SA Fit organizational initiative, which improves students' nutritional awareness, healthy lifestyle skills, and overall mental health with daily physical and enrichment activities like basketball and cooking classes (currently being taught virtually). Students learn recipes that enable them to practice healthy habits at home and cook nutritious meals with their parents during monthly virtual or in-person Family Engagement Nights that also attract the neighboring community and key stakeholders. The funds requested will enable SA Youth program staff to remain focused on keeping students healthy, decreasing learning gaps created during this time, and encouraging students to continue achieving success beyond any circumstance.

Target Goals:

Goal 1: Improve educational achievement.

Goal 2: Develop positive character and values.

Goal 3: Promote healthy lifestyles.

Expected Results:

SA Youth's overall strategic outcomes include increasing a student's knowledge and awareness of the importance that education plays in their life and improving healthy lifestyle skills. We aim to increase the educational achievement of students at all levels (grade promotion and/or high school diploma), so that they may graduate and become young adults who have plans for higher education, vocational training, or a desire to serve their country through military service. Additionally, program staff aims to develop self-discipline, leadership, and consistent study habits in students, which will be even more critical this school year.

Evaluation Plan:

SA Youth utilizes various academic and behavioral reporting formats in order to measure the success of our programs. For example, our OST program uses sign-in rosters, pre- and post-tests, academic and behavior reports from schools, verbal feedback from participants, school administration, and several other measuring tools. Our program team regularly reviews and measures attendance, grade promotions, and behavioral referrals, through Skyward Software. This student data is used to identify any downward trends in student grades, so that remediation is swift and concentrated.

Our YouthBuild program staff also measures daily student attendance and academic improvement throughout the course of the program. Students are required to complete a series of benchmark TABE exams. Additionally, graduation rate, student placement after the completion of the program (e.g. higher education, career, military service), and follow up rates with alumni are measured each cohort. Logic models are also reviewed regularly to incorporate new data that arises.

Plans to sustain project beyond the term of this request:

SA Youth takes an active approach in locating, securing, and maintaining funds following its organizational 2020 Strategic Plan designed by its CEO, executive team, and Board of Governors.

SA Youth receives funding from United Way, government agencies, private foundations, corporations, dedicated individuals, its signature Chips N Salsa event (which will feature a virtual format this year), and local business partnerships that provide in-kind services and goods. Moreover, annual back-to-school and holiday giving campaigns raise additional funds and keep individual and corporate donors engaged year-round.

Although much of the funding received is from government sources, many expenses in support of our programs are not covered by these agencies. Therefore, we implement on-going fundraising efforts and strategies so that hundreds of economically disadvantaged students can continue receiving services.
