Program / Project Description:

Camp Aranzazu has served more than 27,500 children and adults with special needs and chronic illnesses, along with their support staff, since opening our doors in 2006. We are eager to host camp this year and are confident in our ability to do so safely. As always, we will underwrite up to two-thirds of the cost so that financial barriers do not prevent anyone from enjoying our unique form of therapeutic recreation. Camp Aranzazu is a host facility that provides meals and lodging; customizes each camping experience to meet our partners' goals; and facilitates activities under the guidance of our Certified Recreational Therapy Specialists. We also will continue offering "Aranzazu-to-You" (camp-to-go), family camps, online activities, and adaptive sailing--all programs launched last year to serve the campers too vulnerable to attend traditional camp sessions. In total, we hope to serve approximately 1,000 campers this year, or 60% of the number we would host in a typical year.

Our work is more important than ever. Because of the pandemic, the social and emotional needs of children and young adults are not being met. Many children have only recently returned to school. Opportunities to participate in sports remain almost non-existent. Many museums, parks and zoos are only open on a limited basis. For those with special needs and chronic illnesses, whose options were limited before the pandemic, the pandemic has created even more isolation.

Thankfully, Camp Aranzazu provides a unique and an amazingly effective vehicle for addressing these social and emotional needs. Spending time with others who face similar challenges provides those whom we serve with a much-needed sense of belonging. Our activity leaders serve as role models who encourage and support campers as they try new activities and have new experiences. Campers gain independence when they spend time away from home and their usual caregivers. Says Luke, a young cancer survivor, "Camp Aranzazu lets all people, no matter their ability, know what joy is."

Furthermore, research commissioned by the American Camp Association (ACA), the accreditation body for summer camps and youth development, shows that camp offers a unique opportunity for growth due to the opportunities for self-challenge within in a safe and supportive environment. These benefits appear to far outlast the brief period of time at camp. Ultimately, camp helps create thriving adults who have a strong sense of identity, are better at teamwork, and have good interpersonal skills.

We respectfully request a grant of \$35,000 from the Harvey E. Najim Charitable Foundation to underwrite the cost of our October camp serving families from Be an Angel and to offset an expected loss of revenue. About half of the Foundation's gift will underwrite a unique respite weekend for San Antonio-area families with a child facing multiple disabilities or profound deafness. The remainder will help us to offset the loss of camper fee and philanthropy revenue. The need to run our facilities as normal contrasts sharply with the capacity limits outlined in the ACA's coronavirus mitigation guidelines. We also are cautious about our fundraising success in light of the turbulent economy and uncertain time frame for reopening. An operations gift will help us maintain our extensive facility and retain our highly-trained and very dedicated staff. Looking ahead, an operations gift will help us continue to serve some of Texas' most vulnerable children and adults - the special populations who have had even fewer opportunities to connect with others, enjoy nature, and learn new skills the past year.

Evaluation Plan:

At the end of each camping session, partner staff and campers complete an online survey to identify the effectiveness of our programs, popularity of different activities, and satisfaction with facilities, services and staff. We also ask our stakeholders to suggest areas of improvement.

The relationships our program team members build with partners provide us with extensive opportunities to discuss and evaluate our programs each year. As part of our efforts to continuously improve, our staff uses the surveys to guide debrief sessions throughout the off-season. Each debrief session provides insight into how our staff can better serve our partners and gives further opportunities to collaborate with partner staff.

Plans to sustain project beyond the term of this request:

Camp Aranzazu is sustained through a wide array of funding sources including, but not limited to, Individual Donations 9%, Corporate 1%, Foundations 35%, Special Events 27%, Program Fees 27%, and miscellaneous income 1%. We are especially excited to continue "Holiday Bells & Shells" for a fourth year; this year's event will take place on November 17-18, 2021, at the Argyle and the San Antonio Gun Club.
