Food, Shelter and Clothing

Program / Project Description:

The Whole Student is Texans Can's multi-faceted program with the goal to care for the whole child and address the obstacles that keep students from success and economic independence. Over ninety-five percent of Texans Can students are from low-income families, and all Texans Can campuses are strategically located in areas where need is highest. As students' advocates, Texans Can Academies understands that each student struggles in different ways, and those hardships make attending school difficult and, in some cases, nearly impossible. Through the Whole Student program, those barriers are removed and students can attend and even thrive in their classes.

At Texans Can Academies - San Antonio, the Whole Student program focuses on making sure students have access to services within 10 days of enrollment, meeting the organization's priorities of providing increased access to healthcare, including dental, vision, and mental health services in the San Antonio area. Services offered to students include but are not limited to immunizations, therapy, nutritional support, social work, drug-abuse programs, eye exams and eyeglasses. Without these resources, Texans Can students would be unable to focus fully on their classes and education.

Currently, Texans Can - San Antonio is cultivating relationships with multiple partners who are being asked to take a larger role in students' lives by supporting numerous aspects of the Whole Student program. Specifically, San Antonio's Development Council has recently secured funding to support a profession-standard Student Assistance Program, providing targeted mental and behavioral support, and has expanded its career-readiness offerings, providing safe passage from graduation toward rewarding fields. All of these efforts are crucial to the Whole Student programming.

In support of part of these crucial efforts, funds sought through this grant proposal will support the efforts of Texans Can - San Antonio's Dragon Market, a site crucial to the Whole Student program where students receive resources supplying several basic needs. At the Dragon Market, students find hygiene products, including feminine hygiene products, household cleaning products, baby care products, and, through a partnership with the San Antonio Food Bank, groceries. Additionally, the Dragon Market supplies school uniforms.

Studies indicate pronounced need for such supports, especially in school. Children who through want of resources are unable to maintain basic hygiene and cleanliness experience social isolation, even bullying, and may be discouraged from completing school. Adolescent girls in poverty, who may have to choose between food and feminine hygiene products, may stay away from school for days at a time, leading to delayed graduation. This "period poverty" affects 1 out of 5 girls nationwide, according to a report in the Nashville Tennessean. Clearly, the Dragon Market meets an important need which is basic to academic success at Texans Can - San Antonio.

Last year, the Dragon Market provided needs for 77 students and their family members, totaling approximately 250 individuals. In the next year, the market will be available to 650 potential students (Texans Can's total number of students), with impact on their family members, including any infants or small children belonging to teen parents enrolled at the school. These resources will help keep students in school not only by removing a substantial economic barrier, but also by providing psychological relief and encouragement to continue their path to success.

Evaluation Plan:

The Dragon Market's services will be evaluated according to the number of students and family members served, by inventory moved, and by student and staff surveys pre- and post-school year.

Plans to sustain project beyond the term of this request:

Texans Can Academies has 35 years' experience serving low- to moderate-income students at risk of not graduating. Texans Can will continue to offer as many services as possible for the Whole Student program. The Dragon Market specifically, and the Whole Student program more generally, will ensure a continued increase in graduation rates and help break the generational cycle of poverty.

Because the Whole Student is essential to its mission, Texans Can will continue to seek funding on an ongoing basis from multiple partnerships, events, and other efforts. Texans Can is strong, and its fundraising will keep this program alive because under-served students will continue to need Texans Can to graduate high school and embark on their lives as economically independent adults.
