#### **Program / Project Description:**

This project will support families and schools as they navigate remote learning during COVID-19 by providing virtual learning support to school-aged children. As COVID has demonstrated, schools provide more than education - they serve as free child care, social emotional support to children, safe havens for unstable homes, and more -- and allow families, particularly single mothers, to go to work to earn a living with the peace of mind that their children are safe. COVID-19 has disrupted normal school routines, and school districts establishing multiple plans for the fall, from delayed opening to remote learning, and are establishing contingency plans for the full school year, should virus cases begin to spike again and force schools to close during the year. As parents and schools have learned, remote learning presents an educational and equity challenge that goes beyond simply providing a Chromebook or laptop. Challenges include unreliable wifi, parents who are unable to work from home to supervise their children and provide technical or educational support, and the need for in-person additional support for students who learn differently. With these challenges, parents and students will lose instructional time and confidence and, more importantly, parents who must work outside of the home will lose full-day child care and supervision that schools provide. These challenges have exacerbated the economic and emotional stress on lower income families, single mothers, and families who have children with social-emotional needs or learning differences.

To support families and help schools, YWCA San Antonio will provide in-person child care and educational support for virtual learning for school age children in grades K-5 in from zip codes 78237, 78207, 78228 (primarily Edgewood and San Antonio Independent School Districts) at the Olga Madrid Center, with space available for 48 children; with investment by the Najim Family Foundation, YWCA will provide 20 families 10 weeks of free virtual support. The model is designed as follows:

For children grades K - 6 (Edgewood)

- o 4 certified teachers for academic help and guidance to groups of 8 children to one teacher for academic support
- o 2 additional CDA teachers for 2 additional "rotations" of free play, downtime, quiet reading, activities Specifics:
- o Eight weeks of education and support activities @ \$125/week for 20 children
- o Six "mini" rooms, created by dividers, in the YWCA Olga Madrid Gym
- o Groups with ratios of 8 students to one teacher
- o Students will be required to bring their own or school-issued device

In addition to supporting students in grades K-5, YWCA-SA will support high school students, who have also been suffering during COVID-19 from lack of connection, socialization, and school-sponsored and adult-supervised after school engagement. YWCA's youth programs engage youth in grades 9-12 in service learning opportunities focused on reducing food insecurity by working in our community garden and distributing food to the community in partnership with the San Antonio Food Bank. With support from the Najim Foundation, YWCA will provide after school activities for high school students to engage in service, work outdoors in our community garden, and build workforce skills. YWCA will offer service opportunities on-site at the Olga Madrid Center twice weekly and one Saturday per month to offer high school students the opportunity to earn volunteer hours, engage with other students under the supervision of an adult youth service manager in a safe environment, develop workforce skills, and address food insecurity.

The model includes

- o Serving 20 high school students in grades 9-12
- o Two days per week and one Saturday per month at Olga Madrid Center
- o Specifics:
- o Focus on racial justice, food insecurity, building a community garden, distributing food from food bank
- o Building leadership skills of youth by emowering teens to lead program
- o Building workforce skills including organizations, team-building, volunteer management

YWCA partners with, and follows best practices developed by, community organizations and City entities -- from participating in the UP Partnership, working with Communities in Schools, serving as a delegate agency for the City's Early Head Start (EHS) program, and participating on the newly created PreK - 12 Consultation Group to support school districts during COVID. As a licensed and Texas Rising Star-3 accredited child care facility, YWCA has been open for child care since March 16, when most of the City closed down, serving essential and front-line health care workers, and have established a health and safety protocol, which follows the guidelines set by the Centers for Disease Control (CDC). We have experience in navigating the challenges of operating a facility during a pandemic, following best practices for protecting children and staff from becoming infected and spreading the virus. Moreover, we have served as first responders to families in need of food, health care, and shelter by providing emergency food and resources and referring these families to our many nonprofit partners in the community. As a community hub for the West Side of San Antonio, YWCA has played a critical role in creating a safety net for the most vulnerable in our City.

#### **Evaluation Plan:**

YWCA will evaluate quantitatively and qualitatively:

Quantitatively, we will track hours of educational and educational-support activities, and numbers of children served:

- o Hours:
- o Education: 10 weeks; three hours/day; five days/week GOAL: 150 hours
- o Academic Support Activities: 10 weeks; two hours/day; five days/week GOAL: 100 hours
- o Children:
- o GOAL: 48 children grades K 6 and 20 teens grades 7 12.

Qualitatively, we will survey parents (for children grades K - 6) and parents and teens (for teens grades 7 - 12) to determine their satisfaction with the service.

#### Plans to sustain project beyond the term of this request:

This project will build the human resource capacity and physical infrastructure to support remote learning throughout the year, should schools choose to close due to new COVID cases. YWCA will sustain this program with an approach that has worked throughout its 110-year history: with a committed Board and staff cultivating community partnerships and a comprehensive and diversified fundraising team, engaging the support of dedicated funders/donors. In addition, YWCA will use a sliding-scale fee-for-service model, offering free services for families who need them.

YWCA strives for sustainability by A) Ensuring strong financial management, planning and oversight; B) Advancing leadership capacity, fund development, and governance C) Increasing agency visibility and community support; and D) Developing internal systems that support growth, best practices and mission. Our community partnerships and relationships with funders/donors are integral to our programs' success and maximizing community resources.
